The summer was marked by the G20 in Hangzhou, a new milestone in China's demonstration of its growing influence, but also by the ruling of the Court of Arbitration in The Hague on the islands in the South China Sea. These events highlighted the importance of Asian issues in international relations as well as in the global economic governance. But for Asia, the major event of the last few months was the surprise – as seen from there – of Brexit, which has caused much uncertainty and bewilderment in a continent that had sometimes envied or wished for the European integration or even feared that it may turn into an overly cohesive entity in the face of the rise of other continents, including when it came to assigning the much vaunted "market economy status." Cards are being reshuffled and the election periods that are still producing aftershocks in England or starting in France and Germany will most likely push into

the background the Asian concerns of Europeans. That would be a paradox as well as a mistake at a time when Europe – or its main components – plainly matters so much for Asia.

The activities of our Centre will attempt to reduce the risk posed by the widening of such a gap, as our Centre has always been dedicated to doing. In addition to continuing our "Observatories" for a shared in-depth regional expertise, the organisation of seminars to share perspectives – on cyber issues as well as China "as seen from" – and the participation of our members to Asian forums – such as the "Huai Hai Forum" in Shanghai – will contribute to such a mission.

They will also take place in the ever more concrete context of our scientific research and development cooperation with the various entities of INALCO, which is already home to many of our activities and teams.

Annual International Conference on China

The China Observatory held its annual conference on 27 September in Paris to bring together Indian and French analyses of contemporary China, in particular with respect to China's domestic policy and its international implications, China's military modernization, China and India's neighbors, and China's ambitions in the Indian and Pacific oceans.

Study Day on Cyber Geopolitics in Asia

Organized in partnership with the Castex Chair of Cyber Strategy on 7 July at the Geography Society. About 20 international experts began by making an assessment of cyber issues in Asia before comparing European and Asian stances on cyber security.

A Toughening Regime and Rising Tensions: What Future for Xi Jinping's Presidency?, by Camille Liffran (French-Chinese Centre of Beijing / Asia Centre) Assessment of Xi Jinping's policies, as the 19th Congress of the Communist Party of China (CPC) scheduled for fall 2017 is drawing closer and is likely to see the replacement of a significant number of the members of the Political Bureau.
